PROFESSIONAL EXAMINATIONS IN LAW (TIKANGA MAORI REQUIREMENTS) AMENDMENT REGULATIONS 2022

Made pursuant to section 278 of the Lawyers and Conveyancers Act 2006

INTRODUCTION

1. Title and Commencement

- (1) These regulations may be cited as the Professional Examinations in Law (Tikanga Māori Requirements) Amendment Regulations 2022.
- (2) The commencement date is 1 January 2025.

2. Amendments to Principal Regulation -

- (1) In regulation 1(2), insert at the end of the sentence "with the exception of the Tikanga Māori Requirements, which come into force on the first day of January 2025".
- (2) In regulation 1(3), insert in its appropriate alphabetical order:
 - ""Tikanga Māori Requirements" means:
 - (a) the requirement in regulation 3(1)(a)(ii) that the degree course includes teaching and assessment of the general principles and practices of tikanga Māori | Māori laws and philosophy relevant to the subjects set out in regulations 3(1)(b) and 3(1)(d);
 - (b) the requirement in regulation 3(b), that the subjects of examination shall include tikanga Māori | Māori laws and philosophy;
 - (c) the prescription of the subject of examination which is tikanga Māori | Māori laws and philosophy, as prescribed in the First Schedule."
- (3) In regulation 3(1)(a), insert a new regulation 3(1)(a)(ii):
 - "the degree course includes teaching and assessment of general principles and practices of tikanga Māori | Māori laws and philosophy relevant to the subjects set out in regulations 3(1)(b) and 3(1)(d); and"
- (4) In regulation 3(1)(a), renumber the existing regulation 3(1)(a)(ii) to regulation 3(1)(a)(iii).
- (5) In regulation 3(1)(b), insert a new item to the end of the list of subjects: "Tikanga Māori | Māori laws and philosophy"
- (6) Insert a new regulation 14:

"14. Transitional Provision

- (1) For admission purposes, the Tikanga Māori requirements shall not apply to any person who commenced or completed a Bachelor of Laws or Bachelor of Laws Honours degree before 1 January 2025.
- (2) Regulation 14(1) does not limit regulation 10 which imposes time limitations, and allows the Council to reassess qualifications and impose new requirements."
- (7) Renumber existing regulation 14 to regulation 15.
- (8) Amend schedule 1 by inserting at the end:

"TIKANGA MĀORI / MĀORI LAW (One paper)
